## Public Appointments Chair Northern Ireland Social Care Council

The functions of the Northern Ireland Social Care Council (NISCC) are to regulate the social work profession and other social care workers by promoting high standards of conduct and practice among social care workers and high standards in their training. The NISCC maintains a register of those who can practice within a social care context. It is responsible for improving the quality of personal social services by raising standards in the workforce. NISCC has a duty to secure the interests and welfare of service users and to strengthen public protection and confidence.

Leadership; Making an impact with others & displays a range of political skills; Committing to the non-executive role; Thinking strategically; Analytical thinking; and, Learning and self development.
