#### **NICE Clinical Guideline No 61 – Irritable bowel syndrome in adults: diagnosis and management of irritable bowel syndrome in primary care**

The advice in the NICE guideline covers the care of adults with irritable bowel syndrome, including:

- the support, treatment and advice people should be offered by their GP in diagnosing and helping to manage their irritable bowel syndrome
- circumstances when people need to be referred to a specialist for further tests.

It does not specifically look at:

- irritable bowel syndrome in children and young people under 18 years
- people with other gastrointestinal disorders such as non-ulcer dyspepsia (indigestion with no obvious cause) or coeliac disease.

DHSSPS advises that this guidance is valid for Northern Ireland and endorses it for implementation in HSC.

The HSC sector also should note that;

1. The Department expects HSC organisations to take account of this guidance in the planning and delivery of services to patients with irritable bowel syndrome.
2. This advice does not override or replace the individual responsibility of health professionals to make appropriate decisions in the circumstances of their individual patients, in consultation with the patient and/or guardian or carer. This would, for example, include situations where individual patients have other conditions or complications that need to be taken into account in determining whether the NICE guidance is fully appropriate in their case.
3. This guideline will be reviewed by NICE as and when required.
4. NICE has developed tools to help organisations implement this guidance.
