## Status: Best Practice Guidance

In June 07 the Department issued a series of alerts under Circular HSC (SQSD) 28/2007 relating to medication safety namely:-

- NPSA Alert 18 - Actions that make anticoagulant therapy safer
- NPSA Alert 19 - Promoting safer measurement and administration of liquid medicines via oral and other enteral routes
- NPSA Alert 20 - Promoting safer use of injectable medicines
- NPSA Alert 21 – Safer Practice with epidural injections and infusions

Circular HSC (SQSD) 28/2007 endorsed these four alerts for implementation across HSC, independent and regulated sector organisations by 30 June 2008.

- Criterion 5.3.3(f) (implementation of evidence-based practice through guidance, for example, NPSA guidance).


