RECOMMENDATIONS TO IMPROVE THE SAFE USE OF INSULIN IN SECONDARY CARE

The use of insulin is associated with a relatively high incidence of adverse events, including fatalities, and is largely attributable to a number of systems failures.

Allied to these systems failures the Northern Ireland Medicines Governance Team has developed a series of recommendations and associated actions designed to improve safety in the use of insulin, a copy of which is enclosed.

The actions apply to the Department and the HPSS but given the potential for serious insulin-related adverse incidents the advice is being cascaded now to inform models of good practice.


Further supplementary work is underway through CREST which has already produced guidance in the emergency management of hyperkalaemia in adults, including the safe use of insulin. In addition, the development of a template for a regional Kardex is well advanced which is the subject of recommendation 35.




