## Public Appointments Non-Executive (Registrant) Member Northern Ireland Social Care Council

The Department of Health, Social Services and Public Safety is seeking to appoint a Non-Executive (Registrant) Member to the Northern Ireland Social Care Council (NISCC).

The functions of the NISCC are to regulate the social work profession and other social care workers by promoting high standards of conduct and practice among social care workers and high standards in their training. The NISCC maintains a register of those who can practice within a social care context. It is responsible for improving the quality of personal social services by raising standards in the workforce. NISCC has a duty to secure the interests and welfare of service users and to strengthen public protection and confidence.

### Essential Criteria

**Registrant Member.** A Registrant Member must be on or eligible to register on either the social work or social care part of the Register maintained by the Northern Ireland Social Care Council (NISCC) under the HPSS Act (NI) 2001. Social care workers are those who work in a range of settings, including residential, day and domiciliary care settings. Applicants should note that the successful appointee must hold full registration on either the social work or social care part of the Register with the NISCC by the date on which the appointment is made.

In addition to the requirements above, applicants must also meet the following five essential criteria:

Making an impact with others & displays a range of political skills; Committing to the non-executive role; Thinking strategically; Analytical thinking; and, Learning and self development.
