Public Appointments Chair (Designate) Safeguarding Board for Northern Ireland

The Department of Health, Social Services and Public Safety is seeking to appoint a Chair (Designate) to the Safeguarding Board for Northern Ireland.

The Safeguarding Board for Northern Ireland (SBNI) will have responsibility for improving interagency co-operation on the safeguarding of children and will also have responsibility for monitoring how its member agencies are co-operating together and how they are performing against the statutory duty to make arrangements to safeguard and promote the welfare of children and young people.

The SBNI and the Safeguarding Panels will replace the current Regional Child Protection Committee and Trust Child Protection Panels, which were established under administrative arrangements underpinned by Departmental Guidance contained in Co-operating to Safeguard Children (May 2003).

Essential Criteria

Applicants for the Chair Designate post must meet the following eight essential criteria:

Commitment to the principles and objectives of safeguarding and promoting the welfare of children; A record of achievement of successful outcomes in delivering safeguarding services to children; Leadership; Making an impact with others & displays a range of political skills; Committing to the non-executive role; Thinking strategically; Analytical thinking; and, Learning and self development.
